# NOTICE TO PLAYERS

Play is governed by the Rules of Golf effective January 2023, the Local Rules and Terms of the Competition Card (Hard Card), the Local Rule for this Championship setting a Pace of Play Policy (available at the starting tees), and where applicable, by the following Local Rules, which apply to this golf course:

## 1) Distance-Measuring Devices:

Distance-measuring devices are permitted under 4.3a(1). Any device functionality other than distance (i.e., slope, elevation change, etc.) MUST be disabled. Map features on such devices are prohibited as outlined in item 4f. of the Local Rules and Terms of the Competition (MLR G-11).

## 2) Out of Bounds and Course Boundaries:

In addition to item #1 in the Local Rules and Terms of the Competition, out of bounds is defined by:

- a. Brown / White Out of Bounds stakes.
- b. Inside edge of the road beyond #2 green, behind #3 tee, beyond #5 green, behind #6 tee and the main entrance road to the left of hole #10.
- c. Water's edge when tied into the red *penalty area* back right of #10 green.

Note: The maintenance facility, nursery and practice range are NOT out of bounds.

## 3) Dropping Zone for Yellow Penalty Area Hole #2, #5 and #17:

If a player's ball is in the yellow *penalty area* on hole #2, #5 and #17, including when it is *known or virtually certain* to be in the *penalty area* even though not found, the player may take relief using one of the options under Rule 17.1d, or, as an additional option, *drop* the original ball or another ball in the dropping zone under penalty of one-stroke.

Dropping Zone Location on hole #2 and #5: In the fairway short of the penalty area.

Dropping Zone Location on hole #17: Forward tee short of the *penalty area*.

The dropping zone is a *relief area* under Rule 14.3.

#### 4) Temporary Immovable Obstructions (TIOs):

- a. "Either Side" relief option: The player is permitted to take relief on the other side of any TIO for line of sight interference ONLY. This is in addition to the relief options allowed under clauses b. and c. of Model Local Rule F-23 (Local Rule for TIOs).
  Note: If a player chooses to take relief from physical interference using the procedures in Rule 16.1, the option to take relief on either side is NOT allowed.
- b. Temporary Immovable Obstructions (TIOs) Treat as One: This includes all TIOs connected by blue lines and/or meshing and all highboy tables located throughout the *course*.
- c. Dropping Zones on Hole #12: If a player's ball has line of sight interference, the player may take relief under Model Local Rule F-23, or as an additional option, a player is permitted to use one of the dropping zones listed below even if closer to the hole than where the original ball lies.
  - For a ball with line of sight interference from the TV Tower, Sahalee Member Club (picket fencing, patio and entrance tent), Concession Market, Restrooms or Shotlink camera all located right of and beyond the green.
     Dropping Zone Location: Short right of the green in the rough.
  - ii) For a ball with line of sight interference from the Chase Sapphire Chalet, T-Mobile Chalet and Vendor Service Area all located left of and beyond the green. This additional relief option is not available for the leaderboard left of the green. Dropping Zone Location: Left of the green in the rough.
- d. Dropping Zone on Hole #18: If a player's ball has line of sight interference from the NBC Announce Booth short and right of #18 green, the player may take relief under Model Local Rule F-23, or, as an additional option, the player is permitted to use the dropping zone, provided the dropping zone is not nearer the hole than where the original ball lies.

Dropping Zone Location: Short right of the green in the rough.

#### 5) <u>Returning Scorecard</u>:

In modification to item #9a of the Local Rules and Terms of the Competition, a player's scorecard is treated as returned 15 minutes after all players in the group have left the defined scoring area.

**Play-Off:** In the event of a tie for the Championship, there will be a hole-by-hole play-off on hole #18 and if there is still a tie, the play-off will continue on a hole-by-hole basis, commencing on hole #18, #14, #17 and #18, repeated, until a winner is determined.

Player Only Restrooms: Are located at the #3 tee, #4 tee (permanent restroom), #7 tee, Clubhouse, front right of #11 tee, front right of #14 tee and #15/#17 tee (permanent restroom).
